If you are applying for a permit and are not a licensed contractor, by signing this application you are specifically asserting that the work you are performing is for your own home and is, therefore, exempt from contractor licensing requirements of Minnesota Statutes, chapter 326B. You further acknowledge that performing work without a license when one is required by law is a crime and is punishable as a misdemeanor. By signing this application you also acknowledge and agree that you alone are responsible for compliance with applicable building codes and city ordinances in connection with the work being performed.
