<p><b>NOTE: IF AN EXCAVATION IN THE STREET IS NECESSARY, PLEASE CONTACT PUBLIC WORKS TO MARK AND SAWCUT THE LOCATION OF THE STREET REPAIR. The City shall pay for the extraordinary cost for repairs made on the "City Installed Portion" of water or sewer service where conditions such as main depth, distance to the main or location in a major roadway make the repair cost unusually expensive. The City will either pay for the replacement of the street, curb and gutter or make the repairs themselves at no direct cost to the property owner. If the repair is located beneath a driveway, the property owner will be responsible for all associated driveway repair costs unless the repair extends into the street.
